

# Agreement to Hold Harmless, To Indemnify and Release from Liability

In consideration for the privilege of being allowed to bring Guests\* to engage in recreational activities at the Windsor Marksmen's Association Club,

I, \_\_\_\_\_ hereby agree and understand that:

There are inherent risks involved, including the risk of serious physical injury or death, in participating in the types of activities offered at the club. I also understand that these activities may take place anywhere on Club property and that my guests use of Club property exposes them to these inherent risks, whether they are participating in any activities or not. With the understanding of risks involved, I fully assume all risks and liabilities associated with my guests presence or use of the Club property even if such risks are due to the negligence of the Club, its Officers, Directors, Members, Agents or any other person, including but not limited to the handling and transporting of firearms and ammunition, skeet, rifle and pistol shooting, organized shooting or archery events, lack or inadequacy of warnings, lack or inadequacy of safety devices, lack or inadequacy of instructions and use of any Club equipment or facility.

I, agree that I am legally responsible and I will defend, indemnify and hold harmless the Club, its Officers, Directors, Members, and Agents from any and all claims, suits, demands, causes of action or claimed causes of action by anyone arising from or in connection with my guests use of the Club property including claims of negligence on the part of the Club, its Officers, Directors, Members and Agents.

I, for myself agree that I am legally responsible and that my guests will not sue the Club, its Officers, Directors, Members, Agents, and Employees for monetary damages for personal injury or property damage sustained by my guests while engaging in recreational or any other activity at the Club even if due to the negligence of the Club its Officers, Directors, Members and Agents. I understand that recreational activities shall mean any use of Club property including but not limited to, shooting, walking, driving, use of any Club building and parking anywhere on Club property.

I have read this Agreement and fully understand its terms. I further understand that by signing this Agreement I am assuming substantial legal obligations for my guests. I have not been induced to sign this agreement by any promise or representation and I sign it voluntarily and of my own free will.
